### **CLUC Changes for Special Town Meeting**

The Board went over the handout regarding the proposed changes to CLUC 508.7. B.2. As well as proposed changes to CLUC 615.K.2.b. The Board noticed that 615. J. cites the wrong section. This section cites 502.6 and should be changed to cite 506.2. (Page 192 of CLUC 2018).

Members Weinberg, Greenwood, and Floyd recommend these changes to the CLUC. Members Porter and Dyer do not recommend these changes to the CLUC.

The Board went over the changes requested by Jesse Childs at the June 26, 2018 planning board meeting. Mr. Childs was not present at this meeting. Members Greenwood and Porter think the signage Mr. Childs has told Scott Neal, the Code Enforcement Officer, he wants is already covered in the CLUC. Member Dyer thinks that this issue should be put on the warrant for the townspeople to decide. The Board has decided to change 508.18. 3.k. to say, "up to 100%" instead of "no more than 50%". ANY OTHER BUSINESS – Gary and Karen Westerman – Zoning Change for Woodland Shore Drive Property via CLUC Amendment – Map 5 Lot 45 Sub-lot 16

Mr. Westerman seeks an amendment in the CLUC rezoning his property on Woodland Shore Drive as limited residential. The property is currently zoned as resource protection presumably to protect wading bird habitat. However, Mr. Westerman presented evidence that according to present-day State of Maine wading bird habitat maps the property is not adjacent to any such habitats.
