ANNUAL TOWN MEETING REFERENDUM ELECTION

At the November 2022 election the inhabitants of the Town of Poland moved forward with amending the Town Charter to change how the Annual Town Meeting would be held moving forward.

This change moved Town Meeting from an in person vote to voting at the polls. Absentee ballots are available at the Town Office 30 days prior, just like any other referendum vote, or you may vote in person at the polls.

The Board of Selectpersons will be holding two public hearings to review the Municipal Articles on the warrant in case there are any questions from the public.

BUDGET MESSAGE

The FY 25 proposed budget has a net increase of \$712,598 or 12.51% over FY 24. The largest single line increases in the budget are the following:

- **County Tax increased by \$102K**
- **Paving Reserve increased by \$167K**
- **Revaluation Reserve increased by \$55K**
- **Motor Vehicle Excise decreased by \$75K**
- **TIF allocation increased by \$126K**

The Board of Selectpersons continues to put a high value on keeping the mil rate (tax rate) low for our residents in town while continuing to provide the services our residents are used to having. The solar panels on Public Works salt shed are finally operating and we are using them to offset electrical bills for municipal buildings.

The municipal raise in the mil rate this year will equate to approximately \$127 for \$100K value in property if all articles, including the use of \$575K from unassigned fund balance is approved. If Article 18 is not approved you will see a raise in the mil rate for the municipal budget equate to \$190 for \$100K value in property.

RSU 16 PROPOSED BUDGET

The RSU 16 proposed budget has not been fully developed yet. What we do know is the information that has been given out in different community forums by the Superintendent states that due to items they can't control the budget will be at a minimum \$1.3M dollars more this year.

- Reduction in State Subsidy of \$751K
- Carryover being reduced by \$500K

May 21, 2024 the District Budget Meeting will be held at 6:30 PM at PRHS Auditorium.

June 11, 2024 the Budget Validation Referendum will be at the polls for voter approval.

Articles 1 & 2. relate specifically to choosing a moderator and to electing by secret ballot those running for offices.

Articles 3 – 7. relate to Comprehensive Land Use Code Amendments. Explanations of these articles can be found on our website at www.polandtownoffice.org, emailing Code Enforcement, or by picking up a copy in person at the Town Office.

Article 8. sets the taxes to be due in two equal installments, one in October and one in April. It also allows interest to be charged on back taxes owed. **Budget Committee recommends approval.**

Article 9. To see if the Town will vote to appropriate \$2,988,800 in revenue from non-property tax resources to reduce the total amount authorized to be raised by taxation, and further to see if the Town will authorize the Board of Selectpersons and Treasurer to accept any additional revenues or funds that may be used to reduce the amount required to be raised by taxation. **Budget Committee recommends approval.**

Article 10. To see if the Town will vote to authorize the use of funds from the Jane Ricker Trust, totaling \$74,676, and the AB Ricker Fund, totaling \$22,045, for the purpose of supplementing the Ricker Memorial Library operating budget for Fiscal Year 2024 in accordance with the Town's Investment Policy. **Budget Committee recommends approval.**

Article 17. To see if the Town will vote to raise and appropriate \$20,000 for **Overlay** for the purposes of granting tax abatements and addressing any other tax errors. **Budget Committee recommends approval.**

Article 18. To see if the Town will vote to authorize the Board of Selectpersons to transfer from the Town's unassigned fund balance an amount of \$5,629 for the purpose of funding the Property Tax Assistance Ordinance, and an amount not to exceed \$575,000 for the purpose of reducing the total amount authorized to be raised by taxation for the fiscal year 2025. **Budget Committee recommends approval.**

Money in the unassigned fund balance is excess money we have received from either increased revenue or lower totals in expenses than anticipated over the years. Our financial policy dictates that we have no less than 30 days operating costs for a balance in this fund and our auditors like to see no less than 60 days operating costs in this fund. Last year we dropped into the fund \$575,000 and would like the taxpayers to allow us to take this money and use it to lower the mil rate for taxpayers. Using this amount would bring us to the 60 day mark.

Article 19. To see if the Town will vote to exceed the LD1 property tax levy limit. **Budget Committee recommends approval.**

LD1 looks at the income growth for the State and the municipal growth and only allows us to increase our tax rate by the same percentage or less than the growth equals. This year we are under the LD1 limit with the proposed budget. However, this question is asked every year in case there is an emergency expense such as a fire in one of our municipal buildings or another unplanned/emergency event in Town.



OTHER TOWN NEWS

- **Transfer Station.** Transfer Station hours remain Friday, Saturday, Sunday and Monday from 7 AM – 5 PM. You must have a current transfer station decal in order to use the transfer station. Decals are \$5 and are available at both the Town Office and the Transfer Station.
- **New Phone System.** The Town of Poland recently installed a new phone system. This system allows you to get to all departments, except for Fire Rescue, by calling one number. The number for the Town of Poland is (207) 998-4601. If you know your parties extension you can dial it at any time.

WHAT ARE NOMINATION PAPERS?

Anyone who is a Poland resident and a registered voter in Poland can take out nomination papers to run for open seats. You would come to the Town Office and pick up your papers, which show your interest in being placed on the ballot for election, collect at least 25 signatures from registered Poland voters and then return them to the Town Office before **April 12, 2024 at 4 PM.**

Returning them with the required signatures allows your name to be placed on the ballot at the Annual Town Meeting Referendum Election so you have a chance of being elected into the seat you chose.

New faces are always welcome and this is your chance to become involved in some of the decisions the Town makes.
