MINUTES

February 10, 2022

 Member Norm Davis makes a motion to accept the minutes for January 6, 2022, as presented, seconded by Member Chrissy Kimball. No discussion.

Website

- Recording Secretary Alex Sirois and Chair Cyndi Robbins will meet Monday.
- Alex updates the Committee on the email to Melissa that has not been responded to.

CEDC Goals/Mission Statement

- The Committee agrees on the following mission statement:
 - The mission of the Community Economic Development Committee is to create the conditions for economic growth and improved quality of life by planning for the future of our community's physical, economic, and social needs. We focus on the importance of supporting new and existing businesses, fostering local entrepreneurship, and preserving key assets in our town that will build a strong future based on our rich past.
- Member Norm Davis makes a motion to accept the mission statement, seconded by Member Chrissy Kimball. No discission.

Spring 2022 Business After Hours

- Chair Cyndi Robbins contacted Steve Kinney and Fairlawn golf course to see if they
 would be interested in hosting the Spring Business After Hours event. Fairlawn will not
 be ready in time but will be ready for the fall. She has not heard back from Steve. She
 suggests the Poland Spring Water Museum or tent at Poland Spring Resort as available
 options.
- The Committee agrees that the Poland Spring Water Museum would be a good choice for the event. Cyndi will check availability with Heather Printup.
- A date of April 13th is selected.
- Cyndi will send invitations.

Triathalon

- Member Sheila Foley talked with the outgoing State Park Manager and he loved the idea of hosting a triathlon. Unfortunately, it will depend on the new manager's opinion.
- The town would need a liability insurance policy for an event for approximately \$500,000.
- Sheila knows a group of people who have experience with this and she would like to make sure it is not just a CEDC event. A committee would likely be formed.
 - Stacey is willing to help on that committee.
- Dates of June 18th or 25th are suggested.

NEW BUSINESS

Grant Writer

- Chair Cyndi Robbins is curious if TIF funds could be used to hire a grant writer.
 - Town Manager Matt Garside believes that would be possible only if the project for which the grant is requested qualifies for use under the TIF.

Business Reigstration Fee

Chair Cyndi Robbins was supposed to send a letter to the Selectboard, but before she
can do that she needs a plan. She does not feel comfortable contacting them about it at
this point. For example, if we only charge a fee for a business when they first open, and
they never renew, how do we know they are still in business.

Streetlights and Crosswalks

- Town Manager Matt Garside and Parks and Recreation Direction Scott Segal were looking at a village partnership grant. Ideally, this could fund something along the Route 26 corridor, for sidewalks and/or street lamps.
- Chair Cyndi Robbins is wondering how the CEDC may be able to help with this.

- Matt does not believe the CEDC can be of much assistance yet since the requirements of the grant have not been published. He is just making them aware of the grant.
- Vice-Chair Sheila Foley is curious if the town can use ARPA money for a project like this.
- Matt would need to check to see if that would qualify. There's approximately \$200,000 left, and the plan is to use the balance remaining for road work. The funds must be used by 2026.
- Member Norm Davis also suggests checking with DOT to see what they will allow within the Route 26 right of way.
 - Matt will be meeting with the regional planner to have some preliminary discussions about the project.

SOP For New Businesses

- Vice-Chair Sheila Foley would like to create a "how-to" document for new businesses in Poland. We need something to guide people because the process is very difficult.
- Recording Secretary Alex Sirois will begin putting this together and will run it by Code Enforcement Officer Scott Neal first.
- Member Norm Davis suggests a flow chart.

2022 Business Recognition Award

 Recording Secretary Alex Sirois will put this on the July agenda, for the fall Business After Hours event.

Remaining TIF balances

- Chair Cyndi Robbins asks Town Manager Matt Garside if he has a report of the TIF balances.
 - He does not. Nikki Pratt was working on it this morning, but she needed to complete more time-sensitive tasks for the town meeting first. Matt also wants the Selectboard to review this report before he distributes it.
- Member Norm Davis asks if creating a new TIF has been discussed yet, following the completion of the current TIFs.
 - Matt informs him that the current TIFs have been extended the maximum amount so they will expire for good. A new TIF or TIFs could be created after, but that conversation has not started yet.

CEDC New Member Process

- Chair Cyndi Robbins is curious if Mike Ellis has applied to be on the CEDC.
 - Vice-Chair Sheila Foley informs the Committee that he has submitted his application. He reached out to the Town Office and was told he needed to go to a Selectboard meeting, but is not sure when that meeting is. She reached out to

Nikki Pratt and was told he would be emailed the details about a week before the meeting. She has a process that she follows, however, Sheila feels like it could be improved.

- Selectboard Member Nate McNally is wondering if it would be possible for Nikki to copy
 the CEDC Chair when an application has been received, or have the Chair handle that
 communication so at least the Committee is aware and able to assist the new prospect.
- Town Manager Matt Garside will think about this process.

OTHER BUSINESS

- Chair Cyndi Robbins asks Town Manager Matt Garside if the CEDC is allowed to set up a table outside of the town meeting.
 - Because of COVID, they have asked other groups not to set up outside of the town meeting this year.
- Member Stacey Bsullak is wondering if the CEDC should do a newsletter.
 - o Cyndi thinks this would be a great idea, but to wait until we have news to share.
- The Committee discusses meeting with the Planning Board after the town meeting on either the 4th, 6th, or 7th of April.
- Cyndi asks the Committee if they think the Selectboard should be invited to that workshop.
 - Nate McNally will try to be there.
 - Member Norm Davis thinks they should all be invited, as well as the Code Enforcement Officer.
- Vice-Chair Sheila Foley asks if everyone can look at the goal list created so we can set deadlines for when we want to accomplish them.
 - Signs need to be refreshed.

Can EDC Home be changed to Home? I worry it is a little confusing. This is a tourism website so if someone from out of town goes to the page "EDC" means nothing to them.

The goal with the business directory is to have it live on the visit Poland website entirely so that guests are not redirected to the town's general site. I think before we go too far with images, and change the directory itself, we would want to make sure it can be relocated.

I do have a few more changes that I don't believe I am able to do on my own:

- Can the "Residents Rec" link on the home page be changed to open in a new tab/window?
- Can a new page be created for the trails link on the home page (a blank page similar to https://www.polandtownoffice.org/community-economic-development/business that we can edit the content on)
- Can a new page be created for the education link on the home page (a blank page similar to https://www.polandtownoffice.org/community-economic-development/business that we can edit the content on)
- On the main menu, under the "Visitor's Info" drop-down, can you have the link for "What To
 Do" https://www.polandtownoffice.org/community-economic-development/pages/what-do or the other
 way around, we just don't need the duplicate
- Can "Business Info" https://www.polandtownoffice.org/community-economic-development/business-info instead point to https://www.polandtownoffice.org/community-economic-development/business-info development/business another duplicate
- In the main menu can "CEDC Info" have a page created instead of a redirect to the TOP website

Hey Marissa,

Now that I have access to update things on our website we are hard at work tweaking and updating. The Committee I work for has asked for a change that I am not sure if you guys can make.

Right now if I go to visitpoland.me and click the business directory it points to the directory which is on the Town of Poland website. Once you get there you cannot easily get back to visitpoland.me, also it is clear you are now on a new site and not the visitpoland.me site. They are wondering if it is possible to place this directory on the visitpoland.me site so that you are not redirected.

Part 2 is they are wondering if it is possible to make the directory look a little nicer when you first land on the page. I think we could do this by making an initial landing page with a table of images pointing to categories, but I was wondering if you had a way to make that easier. Can it default to something different than just "business directory all?"

Last request for now, can we add a "Home" button to the top left of the visitpoland.me menu. It is not super clear on how to get back to the home page once you start clicking around the subpages of the site, unless you know to click the logo at the top.
