Financial Report

- The Financial Report for May 2022 includes payroll expenses and dues for \$275 and \$1,000, which Cyndi believes is for the Oxford Chamber and Gems of 26.
 - Neither of the dues expenses were voted on by the CEDC.
 - The Committee discusses the Oxford Chamber and why the CEDC is a member.
 - Chair Cyndi Robbins will email the Chamber to ask that all CEDC Members are added to their email list.

Planning and Development Report

- The following new businesses registrations were received by the Planning and Development Office since the last meeting:
 - o Moonrise Hollow Farm, an agricultural business, located at 12 Alexander Lane.
 - Bearded Bro Home Services, LLC, a handyman, located at 35 Maple Lane.
 - Dollar General, a retail store, located at 1478 Maine Street.
- The following Site Plan Applications were approved by the Planning Board since the last meeting:
 - Image Inc. received approval to build a new innkeepers dwelling at 543 Maine Street.

- The following commercial building permits were received by the Code Enforcement Office since the last meeting:
 - Middle Range Pond Restaurant LLC submitted a permit application for soil stabilization of a 28' x 70' picnic area per a DEP Permit by Rule application dated 05/11/2022 at 640 Maine Street.
 - SBA Towers III LLC submitted a permit application for T-Mobile replacement of (4) antennas, relocation of (4) antennas, and installation of (4) antennas and associated equipment on Duff Road with an estimated construction cost of \$35,000.
 - Poland Spring submitted a permit application to open 285' of roadway with a 6' wide trench at Spring Water Road.
 - Image Inc submitted a permit application to build a new innkeepers dwelling at 22
 Robbins Way, with an estimated construction cost of \$400,000.

Town Signs/Landscaping

- Chair Cyndi Robbins is going to get Mike Ellis a list of sign locations for him to look at.
- Cyndi would really like to ask businesses to adopt signs.
- Member Mike Ellis suggests perennials that are planted intelligently. This would require very little maintenance.

OTHER BUSINESS

- Testing of the sewer system is still taking place. Wastewater from the Maine Inn and Roosevelt House at Poland Spring Resort is now running into the sewer system. The Presidential Inn will be added next week. The issue is now that they have nothing going into the pump system side. Cyndi has agreed to hook the Lodge up instead of Cyndi's Dockside so that something is running into the pump system.
- The CEDC wonders if they can ask Wright-Pierce to come to a meeting so that they can ask some follow-up questions about the project.
- Vice-Chair Sheila Foley informs the Committee that Auburn is promoting that they are
 waiving permit fees for veterans. She is wondering if Poland can do something about
 permit fees for small businesses. Independently-owned businesses that provide
 employment should get some type of fee reduction or exemption.
